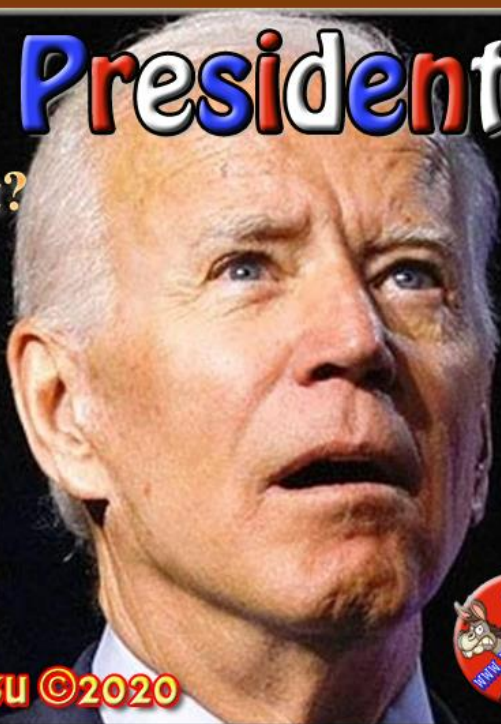


# Joe Biden for President?
